Fuel True Dues Assessment

Please check the appropriate membership category.

Fuel Distribor (Contact the Fuel True office for your company's exact dues amount)

Base Dues - Base Fuel True distributors dues are determined by gasoline and diesel gallonage figures supplied by the Kansas Department of Revenue via the last four Quarterly Motor Fuel Gallonage Reports available to us. Base dues are assessed at 20 cents (\$.20) per thousand gallons reported on both gasoline and diesel.

Supplemental Dues (C-Stores) - Supplemental dues of \$75 for each location reported are added to the base (gallonage) dues or minimum dues.

Minimum Dues - \$350 - The minimum dues amount assessed is \$350 plus applicable supplemental dues.

Maximum Dues - \$5,000 - Once the sum of base (gallonage) dues and supplemental dues reaches the maximum dues amount of \$5,000, no further assessment applies.

Retailers/Convenience Store

Base Dues - Base Retailer Dues are \$195, which covers membership for a retailer with one location.

Supplemental Dues (C-Stores) - Supplemental dues of \$75 for each location reported are added to the base (gallonage) dues.

Petroleum or Tobacco Supplier - \$1,500 annually Petroleum Equipment or Fuel Transport - \$675 annually Convenience Store Equipment or Product Supplier - \$675 annually Professional Service or Allied Products Provider - \$475 annually

Dues-Percentage Tax Deductible

Dues paid to Fuel True are not deductible as charitable contributions for tax purposes, but may be deductible as ordinary and necessary business expense. The portion of Fuel True dues expended on lobbying is 14.5% and is not deductible. For 2023, 85.5% of the amount paid to Fuel True for dues is tax deductible.
